### BY-LAW NO. 2022-034

BEING A BY-LAW TO AMEND BY-LAW 2021-126, BEING A BY-LAW TO IMPLEMENT AN ADMINSTRATIVE MONETARY PENALTY SYSTEM (AMPS) IN THE TOWNSHIP OF LAKE OF BAYS, AS PERMITTED UNDER THE MUNICIPAL ACT (AMENDMENT TO AMPS BY-LAW)

**WHEREAS** the Council of the Township of Lake of Bays, pursuant to Sections 8, 9 and 10 of the *Municipal Act*, implemented an Administrative Monetary Penalty System (referred to as the AMPS Program) to allow the municipality to govern its affairs, respond to municipal issues; while at the same time – ensuring accountability, transparency and protection of persons and property within the Municipality; and

WHEREAS Council adopted By-law 2021-126 on December 7, 2021 and the By-law came into effect on January 1, 2022; and

**NOW THEREFORE** the Council of the Corporation of the Township of Lake of Bays ENACTS AS FOLLOWS that the AMPS By-law 2021-126, be amended by including the following designated By-laws and Administrative Penalties:
